- U.S. students attending TWU may apply for the following loans through the William D. Ford Federal Direct Loan Program:
- Direct Loan undergraduate (subsidized/unsubsidized)
- Direct Loan graduate and professional students (unsubsidized)
- Grad PLUS Loan graduate and professional students
- Parent PLUS Loan dependent undergraduate



- Eligibility for Title IV Funding
- Students who are U.S. citizens receiving Title IV funding must have a minimum high school diploma (or equivalent). Admissions requirements for U.S. students entering TWU from high school can be referenced here: <u>https://www.twu.ca/admissions-aid/admission-</u> requirements/us-students
- -
 - Students are only eligible to receive Title IV funding while enrolled in an eligible program with at least half-time enrolment status. This equates to a minimum of 6 credit hours for undergraduate students and 5 credit hours for graduate students. All eligibility requirements can be found on the <u>studentaid.gov website</u>.
- **Application Process**: To apply for a Direct Loan, students must complete the FASFA (using school code G09486), a Master Promissory Note (MPN), and entrance counselling (for first time loan borrowers) which are available on the <u>studentaid.gov</u> website.
- Award Amount Determination
- Eligibility for Direct Loan need-based funding is determined by the following calculation: Cost of Attendance (COA) *minus* Student Aid Index (SAI) *minus* Other Financial Assistance (OFA) = remaining need
- Eligibility for Direct Loan non-need-based funding is determined by the following calculation: Cost of Attendance (COA) *minus* Other Financial Assistance (OFA) = eligibility for non-need based aid
- -
- The COA for loan calculation includes tuition, books, living expenses, personal expenses and transportation costs for the academic year. SAI is based on the student's (and if applicable, the student's family's) resources as reported on the FAFSA. OFA includes scholarships, grants, loans, and financial assistance that is awarded on the basis of postsecondary enrollment.
- **Loan Limits**: There are limits to the amount of loan funding you may receive on an annual basis which are found on the <u>studentaid.gov website</u>.

- Disbursements: Loan disbursements will occur once in each payment period, and will disburse directly into the TWU student account.

 - **Private Loans**: We recommend that you borrow through the federal student loan before considering private loan options. You can learn about the difference between US Federal



Direct Loan program and private loans at <u>Federal Student Aid</u>. There are a limited number of lenders available for students who are studying outside of the US. We strongly encourage you to explore your options thoroughly. TWU does not have a preferred lender for private loans.

- **Third Party Servicer**: TWU utilizes the services of the National Student Clearinghouse to manage the enrolment reporting process in the Title IV program to which the U.S. Department of Education has oversight authority. Reference: https://www.studentclearinghouse.org/solutions/ed-compliance/
- TWU's Title IV Disbursement Schedule follows the terms and conditions of the Title IV Higher Education Act (HEA), for the eligibility and methods of disbursement. As a foreign school, TWU does not disburse Grants under the program.
- Satisfactory Academic Progress (SAP) Policy: Students are required to maintain satisfactory academic standing in their program of study as established by the University to continue to be eligible for their U.S. loans. - **Borrower Information:** TWU submits enrolment reporting rosters to the NSLDS every 60 days. Any information TWU gathers during this process can be shared with a student's loan servicer in accordance with the terms of the promissory note the student signed prior to receiving their Direct Loan.

 - Online courses, correspondence courses, directed and independent studies courses
 - Internships, with exceptions being teacher placements and counselling placements
 - Programs offered in the Richmond and Ottawa campuses are not eligible for Title IV funding
 - Study Abroad Program: Through the CCCU GlobalEd program, TWU students can study for one semester abroad at another institution. Please note students are not eligible for Title IV funding when enrolled in a GlobalEd study abroad program.

- The student's professor submits a StudentCare alert to the Care Team to notify the student's absence.
- TWU's Director of Student Retention identifies appropriate contacts to investigate (e.g. Residence Assistant, Residence Director, Coach).
- If the student is located and is in need of additional support and If the student is not located on campus, TWU's Director of Campus Life attempts contacts to the student via their documented contacts that can include e-mail, phone and in-person in attempts to locate the student.
- TWU's Director of Campus Life may also reach out to the student's roommates or any other TWU community members known to have had contact with the student for further information.
