## COURSES

### **BUSI 245 TR – FOUNDATIONS OF BUSINESS LAW IN CANADA**

This course gives you an overview of business law with specific focus on the law of contracts. Attention is given to offer and acceptance, consideration, assignment, discharge, breach and remedies available at law.. **Prerequisite: Second-year standing or instructor's consent.**

### **BUSI 346 TR – LAW FOR THE BUSINESS MANAGER**

This course follows up on BUSI 245 and gives you the knowledge and skills to manage a number of business areas that have potential legal risk. Learn all about sale of goods, agency, bailment, insurance and guarantees, negotiable instruments, employment and human rights, intellectual property, real property, mortgages, partnerships, the nature and operations of corporations, credit transactions, and government regulation of business. **Pre-requisites: BUSI 245.**

### **POLS 493 TR – LAW, PUBLIC POLICY AND CULTURAL CHANGE**

Learn about historical and contemporary debate in Canada on what constitutes culture and our contemporary cultural challenges; how Christians interface with that culture and the role of organized religion; Christian critique of culture and the methodologies and perspectives of various entities that seek to influence culture. You will observe first-hand how Canadian culture is formed within the Ottawa setting in their discipline. **Prerequisite(s): None.**

## INSTRUCTORS



### **KEVIN SAWATSKY, J.D.**

Kevin Sawatsky has a Bachelor of commerce and Master of Business Administration from the University of British Columbia and a Juris Doctor from the University of Victoria. Since 1993, he has served on the School of Business faculty at Trinity Western University as assistant and associate professor, School of Business dean, and professor of law. He was appointed University Legal Counsel in 2008 and Vice Provost (Business) in 2011. In 2014, he returned to the School of Business to serve as dean. Sawatsky continues to practise law since being called to the bar of British Columbia in 1993. Focused in the areas of employment, human rights, charities, and construction law, he was part of the legal team providing counsel for TWU at the Supreme Court of Canada.



### **ANNE PENNER, PH.D.**

Dr. Penner has a PhD in Canadian Politics and Comparative Politics. Just after finishing her doctoral dissertation in international trade dispute settlement in 1996, she joined Agriculture Canada's trade policy division and spent 10 years helping to shape Canada's agricultural trade policy and participating in trade negotiations, including at the World Trade Organization in Geneva. From 2006-2012, she founded a communications consulting firm and provided a range of communications-tools to senior government officials. In 2013, she was appointed as a member of the Canadian International Trade Tribunal, a quasi-judicial administrative tribunal that is at the forefront of Canada's trade remedy regime. Occasionally, she advises Canadian and foreign governmental officials based on her academic, government and adjudicative experience. Dr. Penner became interim director of the LLC in August 2021.
