- **NOTE:** You must meet all graduation requirements within five years of beginning course work.
- **NOTE:** You may obtain a Certificate of Completion when your Capstone Project is complete and submitted as appropriate.
- **NOTE:** In order to be eligible for graduation you must complete an Application for Graduation via the Student Portal by July 15 for participation in the fall ceremony and by December 31 for participation in the spring ceremony (there is no fee to apply for graduation). Once your application has been received, a degree audit will be completed for you. This audit will confirm which requirements are still outstanding in order for you to complete your degree. It will also confirm your eligibility to participate in the graduation ceremony.
