Under the framework of cognitive theory and sociocultural theory, his research involves cognitive, metacognitive, motivational, emotional, and behavioral patterns in autonomous and collaborative learning

processes, as well as personal and organizational factors that affect the above; The impact of interactions between individuals and organizations on cognition, behavior, and system; As a leader, how can a teacher construct an effective organized learning system, coordinate and use the personality differences between members that bring conflicts within the organization in terms of cognition, goals and methods to achieve the goals of individuals and organizations; The behavioral patterns of interpersonal interaction in the system, and the laws of the formation and evolution of self-organizing subsystems.
