### **COURSE DESCRIPTION**

This course provides a broad survey of what is considered to be abnormal behavior. Emphasis is placed on a scientific empirical view. The primary focus of the course is on description of various symptoms, syndromes and illnesses. Research and theories on causality of psychopathological and behavioural problems will also be considered as well as treatments of abnormal behavior.

## STUDENT LEARNING OUTCOMES

Students will develop:

- 1. A basic understanding of how abnormal behaviour is defined based on a continuum model of functioning.
- 2. Knowledge of clinical assessment strategies, theoretical perspectives, classification of behaviours, and treatment modalities.
- 3. A practical application of knowledge of specific psychopathological disorders.
- 4. A personal appreciation of mental health issues (lifestyle changes, effects on individuals, families and society etc.) and a curiosity regarding the biopsychosocial-spiritual dimensions of mental health.
